Legislative Column

Well, the election is over and now we have a "lame duck" Congress until January next year, but not sure what bills, if any, will be passed this month before the new congress is in session next year. Even with a lame duck Congress, MOAA still has a mission to protect the benefits of our veterans and active-duty forces. That means MOAA must keep the momentum going to ensure our priorities are made known to Congress now and in the upcoming 119th Congress next year. And yes, the slate is wiped clean and all the bills that were proposed, but not passed, must be reinitiated. Our advocacy campaigns remain an important component of MOAA's mission. Many issues remain. The entire list is on the MOAA website under the Legislative Action Center. Please take time to review this list, and if not previously taken action to make your voice known, please do so.

MOAA states "What the year-end legislative sprint may mean for pay and benefits" in the November 26, 2024 MOAA Newsletter:

The 118th Congress returned to Capitol Hill the week of December 2nd and is set to end its work on or before Dec. 20. Lawmakers in this lame-duck session have a long list of tasks left to accomplish in that short span, many of which will affect the pay and benefits of those who serve and have served, their families, and their survivors.

As legislators and their staffs scramble, MOAA will continue its work across multiple channels to preserve service-earned benefits and strengthen military readiness. While this will take many forms — from supporting new legislation near the end of the session to pushing older bills past the finish line — three key priorities are taking shape as the year winds down.

Here's a look at these areas, what the outcomes might mean for you in the coming year and beyond, and how you can support MOAA's efforts. Keep up with the latest on all these issues and more at MOAA's Advocacy News page.

The NDAA

The annual National Defense Authorization Act (NDAA) serves as a vehicle for many MOAA-backed legislative priorities, and the FY 2025 version is no exception. The House-passed version includes:

A 15% pay raise for junior enlisted servicemembers, in addition to the 4.5% pay boost for all ranks – a meaningful step toward strengthening the current and future force.

A restoration of the Basic Allowance for Housing (BAH) to cover 100% of housing costs, albeit for a single year; an expansion of the Basic Needs Allowance (BNA) to reach more lower income servicemembers; and a review of Basic Allowance for Subsistence (BAS) rates aimed at assisting military families.

TRICARE updates such as adding pregnancy as a Qualifying Life Event (QLE) under a pilot program, and improvements designed to align family planning benefits with commercial plans.

Family support ranging from more in-home childcare locations to better benefits for DoD childcare employees to flexibility for federally employed military spouses seeking to keep their position during a PCS move.

Senate actions on these initiatives are currently undetermined.

MOAA members should remain engaged with their representatives on the many important issues that make up the NDAA. MOAA's Legislative Action Center offers several prewritten messages that can be sent with only a few clicks and convey your feelings as a constituent; these messages can be personalized for a greater impact:

The Budget

Continuing a trend lasting decades, Congress did not pass a budget before the end of the fiscal year and instead put forth a continuing resolution (CR) to keep the federal government running. That resolution runs out Dec. 20 – just before the end of the congressional session – meaning lawmakers will need to pass a full budget by that point, pass another CR ... or allow the government to shut down.

A shutdown would prove disastrous for servicemembers who would work without pay, and for veterans and retirees seeking care and benefits from agencies which would be working with only the most essential personnel available. But a follow-up CR comes with its own long list of problems – misaligned funds leading to waste across DoD and other departments, a full stop on new construction that could benefit quality of life programs, and potential disruptions to training and other military activities which would denigrate mission readiness.

By passing full DoD and VA appropriations as part of a comprehensive (if overdue) FY 2025 budget, law-makers can show their true commitment to supporting our servicemembers and veterans. MOAA will continue its work with the 118th Congress on this issue and stands ready to press the 119th Congress to move faster on these critical budget bills to avoid uncertainty and confusion for the wider uniformed services community.

The Dole Act

Many of Congress' year-end legislative priorities will take the form of omnibus bills, and the Senator Elizabeth Dole 21st Century Veterans Healthcare and Benefits Improvement Act (H.R. 8371) is a prime example. The Dole Act, supported by MOAA and more than 50 other organizations, represents a bipartisan bundle of veteran and caregiver benefit improvements that will provide a lifeline to some of those who need one the most – especially those who rely on VA benefits as their main source of support. Already long delayed, MOAA's work to move the bill forward recently saw some success with overwhelming House passage November 18.

The bill includes upgrades to all manner of support systems:

Pilot programs designed to expand VA-provided assisted living options, improved at-home care for aging veterans, multiple improvements to caregiver support programs, and more important changes for homeless veterans.

- VA employment programs
- survivor benefits
- suicide prevention efforts.

Bottom line: The 118th Congress has yet to pass meaningful, wide-ranging veterans' legislation since it was sworn in nearly two years ago, and veterans and their families cannot afford to see this bill fail to reach the president's desk.

Unlike the must-pass NDAA and the looming shutdown, the Dole Act risks falling off the legislative radar during a busy year-end session.

Major Richard Star Act (H.R. 1282/S.344)

The Major Richard Star Act would authorize combat-injured veterans to receive their earned DoD retirement pay for years of service and their VA disability compensation for lifelong injury.

Currently, these combat-injured (and often seriously disabled) veterans are subject to a cost-saving offset where their retirement pay is reduced for every dollar of VA disability received.

To reduce earned retirement pay because of a combat disability is an injustice; the compensation for these injured veterans is not the place to achieve savings. Currently, The House has 326 co-sponsors for this bill and the Senate has 74 co-sponsors.

MOAA Urges Swift Passage of FY 2025 NDAA

MOAA believes the Fiscal Year 2025 National Defense Authorization Act (NDAA) includes significant quality of life improvements for servicemembers and their families, expands and updates key benefit programs, and requires key reports designed to ensure continued, meaningful congressional oversight.

For these reasons, MOAA supports swift passage of the legislation, which has become law every year since 1961. The bill passed the House 281-140 on Dec. 11 and will move to the Senate in the closing days of the 118th Congress.

"MOAA is extremely grateful to the lawmakers and their staffs who crafted this bipartisan legislation," said Lt. Gen. Brian T. Kelly, USAF (Ret), MOAA's president and CEO. "We are especially appreciative of the work of the House Armed Services Committee's Quality of Life Panel, whose report served as the foundation for the House bill and whose recommendations have, in many cases, become meaningful parts of the final legislation now under consideration.

MOAA believes this legislation will make a real difference in the quality of life and quality of service of our uniformed servicemembers and families.

This legislation recognizes strong national defense and readiness start with having strong people and families and appreciates that the two are undeniably linked."

Kelly highlighted a number of MOAA-endorsed provisions in the bill, to include:

- Military Pay Raise and Junior Enlisted Pay Increase: Increased junior enlisted pay by 14.5%, with an increase of 4.5% for all others.
- Unaccompanied Housing: Improvements include authorizing the services to provide free broadband internet access to servicemembers residing in unaccompanied housing, and the expansion of the DoD Housing Feedback System to include unaccompanied housing.
- Basic Needs Allowance: An increase in the threshold from 150% to 200% of the federal poverty guidelines would increase the number of military families eligible for this vital assistance program.
- Military Family Support: Improvements include more child care coverage for military spouses seeking employment, a 100% discount for DoD child care providers on the care of one child and reduced costs for additional children (standardizing the benefit across the departments), and upgrades to the portability of professional licenses of servicemembers and military spouses.

- TRICARE and the Military Health System: Improvements include a referral waiver for servicemembers seeking physical therapy, nutrition, audiology, optometry, and podiatry services in military treatment facilities.
- The elimination of TRICARE contraception copays to align with federal requirements for commercial health plans.
- Licensure flexibility allowing TRICARE mental health providers to provide tele-mental health care to servicemembers and their families without regard to the location of the provider or the patient.
- Travel Expense Reimbursement: Effective in January 2027, DoD would reimburse reserve component travel and some related expenses for servicemembers who travel over 50 miles to inactive duty training (IDT) and muster duty.

"These efforts to support the military community and provide for the all-volunteer force show the great strides possible when lawmakers from both sides of the aisle work with stakeholders like MOAA and fellow military service organizations," Kelly said. "We look forward to Congress moving on this legislation without delay, and for lawmakers to complete their appropriations duties – including a full DoD budget – along-side these measures."

- 4. **Networking with fellow officers**. Chapters include second-career members in the work force and retired service members who have contacts in their communities that can be valuable to transitioning officers.
- 5. **Stay informed.** Chapter newsletters, websites, and meetings provide you with the latest information on local, state, and national issues and changes to military benefits.

MOAA chapters unite active duty, former, and retired officers from every branch of service, including National Guard and Reserve, as well as surviving spouses, offering the opportunity to connect with others with similar backgrounds and interest and develop close and lasting friendships.

MOAA Store and ROTC/Junior ROTC Items

The MOAA store has re-opened at https://moaa.estore.shop/. In addition to promotional gear, you can find ROTC and Junior ROTC (JROTC) award certificates (in stock now) and medals (place orders now for backorders to be shipped when medals are in stock, expected by the end of April). Electronic certificates may be customized and downloaded online at any time. Note that medals have been updated to reflect all eight uniformed services, and JROTC certificates have been updated with language more appropriate to high school students rather than ROTC students.

The cost of medals to affiliates will remain at \$3.00 per medal due to a MOAA subsidy. Additionally, the store recently added the USPS live rate to shipping options, providing a lower-cost alternative.
